Ms. Bambenek was found in violation of A.R.S. 32-2044 (1,4,6,13 and 20). She was required to complete 6 hours of continuing competency in each of the following areas: Cardio-Pulmonary Evaluation, documentation and billing; pass the AZLaw exam and engage in monthly monitoring. Ms. Bambenek has completed all requirements and continues to undergo monthly monitoring. Board Order #15-30 is set to terminate on April 24, 2017.

Board can either elect to grant early termination of Board Order #15-30 or continue with monthly monitoring until the termination date.

Ms. Bambenek provided an opening statement to the Board and was there to ask any question the Board had.

Mr. Brown asked Ms. Bambenek if Mr. Scott King was also her attorney and Ms. Bambenek stated that Mr. King was her attorney in the matter.

Mr. King was unable to appear due to an illness that required hospitalization. Ms. Bambenek stated she felt comfortable continuing without her attorney. Ms. Baskin, Assistant Attorney General advised Board to continue the case until Mr. King was available to represent Ms. Bambenek.
