Probation for 18 months with the possibility of early termination after successful completion of the following terms:

Practice restriction: dry needling to the spine between C1-T12 is restricted until ordered dry needling continuing education coursework is completed.

Complete within 18 months:

- Twenty-five hours of **Continuing education** in the area of Dry needling addressing the upper extremity and spinal column; course shall be a hybrid delivery including an online and in person component
- Three hours of Continuing education in the area of Billing and Coding
- Six hours of **Continuing education** in the area of Documentation

Continuing education courses must be pre-approved, may be completed online unless otherwise specified, and do not count toward renewal requirements.

Professional monitoring to include a full practice audit as well as clinical monitoring to occur on a monthly basis. Clinical monitoring shall include the review of a minimum of 5 records per month for a period of 6 months. The purpose of the records review is to assess initial evaluations, treatment notes, progress notes, and discharge summaries across multiple 3rd party payors and cash payers. Monitoring reports shall be submitted by the monitoring company to the Board on a monthly basis.

Professional monitoring is eligible for early termination after 3 consecutive monthly reports demonstrate that Mr. Abrahams has met minimum practice requirements and is compliant with the

Board's statutes and rules.
