A complaint against the certificate of Ms. May was filed by her former employer which alleges Ms. May was working with patients while impaired. We have received witness statements and the results of two breath tests. We are awaiting the results of a urine tests. The two initial urine samples were not accepted by the lab. I have discussed the case with Ms. May and through work with Ms. Baskin, the attached consent agreement has been sent to Ms. May. The consent agreement indefinitely suspends Ms. May's certificate and requires her to undergo a substance abuse evaluation.
