#### 5) COMPLAINTS, HEARINGS, INVESTIGATIONS and COMPLIANCE

- c) Initial Review, Discussion and Action on Complaint
  - i. Complaint #16-10; Armando Cruz, PTA

Mr. Cruz was present and was represented by Mr. Flynn Carey, Esq.

Ms. Donahue provided a summary of the case for the Board. The Board opened a complaint following notification of arrest and conviction for Facilitation to Sell a Dangerous Drug. Mr. Cruz pled guilty to Count One: Facilitation to Sell a Dangerous Drug, Methylenedioxymethamphetamine ("Molly)." He was sentenced to 18 months of probation, 100 hours of community service, completion of a cognitive skills class and random drug screens. On January 16, 2016, the court granted early termination and discharge from probation. The court also reduced his charge to a class one misdemeanor. Mr. Cruz did not notify the Board within the 10 day requirement pursuant to § A.R.S. 32-3208.

Mr. Cruz and Mr. Carey provided an oral statement.

The Board review and discussed the case. The Board asked questions of Mr. Cruz.

Ms. Richardson moved the Board offer a consent agreement to include a \$250 civil penalty to be paid within 60 days for failure to report the criminal charges within 10 days. If this is not accepted within the 30-day time fame it will be referred to informal hearing. Dr. Miller seconded the motion. Following review and discussion the motion passed.

- a) Informal Hearing and Possible Action
  - i) Complaint #15-24; Heather Bily, PT

Ms. Bily was present and was represented by Mr. Nick Meza, Esq. The Board members and Board staff introduced themselves. Both Ms. Bily and Mr. Meza introduced themselves. Ms. Richardson read a summary of how the hearing would be conducted and reviewed the possible outcomes of the hearing. Ms. Donahue and Ms. Bily were sworn-in as witnesses.

Mr. Brown read the allegations against Ms. Bily:

- A) Engaged in the performance of substandard care by a physical therapist assistant, including exceeding the authority to perform tasks selected and delegated by the supervising licensee regardless of whether actual injury to the patient is established.
  - a. In review of the patient record:
    - i. Treatment remained consistent across the episode of care

- ii. Each date of service therapeutic exercise and manual therapy was performed.
- iii. May 20, 2015 measurement was taken indicating an increase in knee flexion to 104 degrees
- iv. Patient did report pain at each visit.
- v. Patient did report a decrease in pain medication and increase in pain with difficulty sleeping the night before on May 20, 2015.
- b. Ms. Bily did contact the patient and spoke to her regarding her care and symptoms on May 27, 2015.
- c. Ms. Bily did discharge the patient on May 27, 2015 following confirmation from the patient that she was to seek services at another facility.
- d. Ms. Bily did communicate the patient's communication on May 27, 2015 to the physician.
- e. Physician's note on June 8, 2015 indicated gait without a limp and full AROM without documentation of patient complaint.
- B) Failed to maintain adequate patient records. For the purposes of this paragraph, "adequate patient records" means legible records that comply with board rules and that contain at a minimum an evaluation of objective findings, a diagnosis, the plan of care, the treatment record, a discharge summary and sufficient information to identify the patient.
  - **a.** Documentation of manual therapy may not enable another therapist to be able to assume the patient's care at any point in the course of therapeutic intervention.
  - **b.** Strength measurements are inconsistent with documented AROM measures as documented in the initial evaluation.
- C) Failed to obtain the patient's consent before examination and treatment and document the consent in the patient's record.
  - **a.** Patient intake information does not contain a signed patient consent to treatment.
  - **b.** Ms. Bily in the initial evaluation documents:
    - i. "Patient was instructed in a HEP, completed treatment, and verbally understands rationale. All questions were answered to the patient's reported satisfaction."

Mr. Meza and Ms. Bily provided an oral statement.

The Board reviewed and discussed the case. The Board asked questions of Ms. Bily.

Ms. Bily and Mr. Meza provided a closing statement. Mr. Meza stated that Mr. Bily took it upon herself and completed a documentation course.

The Board deliberated.

Dr. Miller moved the Board dismiss the case. Ms. Richardson seconded the motion. Following review and discussion the motion passed by roll call.

- b) Review and Possible Action on Lifting Stayed Civil Penalty:
  - i) Complaint # 14-28; Mark Nickel, PT

Mr. Nickel was present and was not represented by legal counsel.

Mr. Brown provided a summary of the case for the Board. Mr. Nickel entered into a consent agreement on July 24, 2015, for violations of A.R.S. 32-2044 (14) and (20). He was placed on nine (9) months of probation and required to complete six (6) hours of continuing education specific to documentation and six (6) hours of continuing education specific to ethics. Mr. Nickel was to complete the requirements of Board Order #14-28 by April 29, 2016.

Mr. Nickel sent, via e-mail, on April 29, 2016, a request for a 4 month extension of Board Order #14-28. Mr. Nickel had not completed the documentation continuing education requirement within the 9 month timeframe. The request for extension was denied on May 24, 2016.

The matter before the Board is consideration of lifting the stayed civil penalty of \$2,000.00 as outlined on page 9 of the consent agreement. If the Board finds Mr. Nickel failed to comply with the terms of the Order, the Board may lift the stay and impose the civil penalty to be paid within 30 days.
