1) Case No.18-13, Aaron Temple, PTA

A) Charged unreasonable or fraudulent fees for services performed or not performed.

- 1. Mr. Temple acknowledged that he started the recordkeeping application at the start of scheduled appointments "as is commonly done by PTAs" even if the patient was not present.
- 2. Per Mr. Temple's response, he acknowledged that he used the time waiting for patient PV and LL to perform treatment related activities, such as reviewing the patient's treatment plan.
- 3. Mr. Temple billed patients for therapy without providing services on two occasions.
- 4. Per the Compliance Investigative Report the disallowance for the two occasions were 11 minutes for patient PV on 3/9/18 and 30 minutes for LL on 3/20/18.
- B) Made misleading, deceptive, untrue or fraudulent representations in violation of this chapter or in the practice of the profession.
 - 1. Mr. Temple acknowledged that he started the recordkeeping/billing application at the start of scheduled appointments regardless if the patient was present to begin the treatment session.
 - 2. Mr. Temple acknowledged that he used the time waiting for the patient to perform treatment related activities, such as reviewing the patient's treatment plan.
 - 3. Mr. Temple did not bill minutes if the patient ran over on their planned treatment time.
 - 4. Patient record for PP and LL do not reflect the actual minutes nor time in skilled therapy activities. Aaron stated that he recorded their scheduled start and end time as the billed time.
 - 5. Mr. Temple states that he "never received thorough training on policies or procedures. He cannot recall a time when RehabCare had any training specifically dedicated to proper timekeeping."
 - 6. Per the training log, Mr. Temple received training in procedures related to recordkeeping and skilled vs. unskilled care.
 - 7. Mr. Temple stated that some of his co-workers were billing for documentation without the patients being present. Per the Compliance Investigative Report, therapy staff were interviewed as to their understanding of correct timekeeping procedures. None of Mr. Temple's co-workers that were interviewed were billing for patient time if the patient was not present for treatment.
 - 8. Security footage identified Mr. Temple standing around without a resident(patient) present during the time he was billing for patient PV on 3/9/18. Time stamp on the screenshots provided by RehabCare show Mr. Temple in the Int Pool Room area from 1:03:51 to 1:11:10.

Mr. Greer seconded the motion. Following review and discussion the Both Ms. Hunter and Mr. Greer withdrew their 1^{st} and 2^{nd} motion.

Following discussion on the allegations Mr. Greer moved the Board adopt the following Findings of Fact:

1. The Arizona Board of Physical Therapy is that body politic created and empowered pursuant to A.R.S. §32-2001 *et seq.* to administer the laws of the State of Arizona relating to the practice of physical therapy.

2. Respondent holds Certificate No. PTA-009935 to practice as a physical therapist assistant in the State of Arizona.

3. Respondent acknowledged that he started the record keeping application at the start of scheduled appointments "as is commonly done by PTA's" even if the patient was not present.

4. Respondent acknowledged that he used the time waiting for patient PV and LL to perform treatment related activities, such as reviewing the patient's treatment plan.

5. Respondent billed patients for therapy without providing services on two occasions.

6. The disallowance for the two occasions were 11 minutes for patient PV on 3/9/18 and 30 minutes for LL on 3/20/18.

7. Respondent did not bill minutes if the patient ran over on their planned treatment time.

Patient record for LL and PV do not reflect the actual minutes nor time in skilled therapy activities.
Respondent affirmed that he recorded their scheduled start and end time as billed time.

9. Security footage identified Respondent standing without a patient present during the time he was billing for patient PV on 3/9/18.

10. Respondent affirmed that he did not review patient records on his phone.

Respondent must submit to Board staff for approval prior to beginning the continuing education courses, a syllabus of each course. Respondent shall provide documentation to Board staff that the course was completed prior to any termination of probation is considered.

- a. Respondent shall take and complete a minimum of three (3) hours of continuing education in the area of **Ethics.**
- b. Respondent shall take and complete a minimum of six (6) hours of continuing education in the area of **Billing and Coding.**
- c. Respondent shall take and complete a minimum of six (6) hours of continuing education in the area of **Documentation**.

Jurisprudence Exam: Respondent shall take and pass the Arizona Jurisprudence Examination (AZ Law) within twelve (12) months from the effective date of this order.
