Ms. Richardson moved the Board offer Mr. Permenter a Consent Agreement to include 2 years' probation and monitor of practice in administrative and PTA role, 8 hours of continuing education in ethics, gave credit for documentation course previously taken and a \$2,500 civil penalty. If Mr. Permenter fails to accept the consent agreement the Board will forward this case to an Informal Hearing Mr. D'Appollonio seconded the motion. Following review and discussion both Ms. Richardson and Mr. D'Appollonio withdrew their first and second motion.

Ms. Richardson moved the Board offer Mr. Permenter a Consent Agreement to include 4 years' probation minimum of 2 years with option of early termination and minimum of 6 months monitor with three (3) consecutive months of receipt of monitor reports evidencing full compliance of practice in administrative and PTA role. Must appear before the Board to request early termination. Monitoring shall be within thirty (30) days from the date of completion of the continuing education requirements. Mr. Permenter must complete 8 hours of continuing education in the area of ethics, 8 hours of orthopedic treatment, 8 hours of billing and coding, 8 hours of treatment of medically complex patients, 6 hours of documentation, which he will receive credit for the course previously taken, successfully pass the AZ Law Exam, to be completed within 6 months and pay a \$2,500 civil penalty to be paid within 12 months. If Mr. Permenter fails to accept the consent agreement the Board will forward this case to an Informal Hearing. The Board shall bring back in two weeks in a special meeting to consider the renewal of Mr. Permenter Physical Therapy Assistant certificate and the possible consent agreement.
