Aubrey Godwin and Jerry Perkins came forward to address the Board. Mr. Godwin is the Director for the Arizona Radiation Regulatory Agency (ARRA). Dr. Godwin stated that it has come to the attention of the ARRA that some physical therapists have obtained Class 3b and Class 4 non-ionizing lasers, which his agency regulates. The ARRA tried to register the lasers to the physical therapists, but found that the laws identifying which licensed healthcare providers could register these lasers did not include physical therapists. Director Godwin stated that they are looking to work with the Board and the physical therapy community to educate physical therapists about the laws regarding the certain classes of lasers and to begin a discussion about have the laws updated to allow physical therapists to register the lasers and act as medical directors for their use.

The Board asked questions of Director Godwin and Mr. Perkins. Stephen Dillion, PT was present and addressed the Board. Mr. Dillion is an instructor at an Arizona Physical Therapy program and discussed the use of lasers in the program. In addition, Cynthia Driskell, PT with the AzPTA State Government Affairs Committee was present for discussion. The Board instructed Mr. Brown to put together a communication to be sent to all licensees and certificate holders regarding the laws regulating Class 3b and Class 4 non-ionizing lasers and work with the ARRA on any updates that may be done to the regulations.

- b) Senate Bill 1154; Review, Discussion, and Action on Creating Rules to Establish the Standard of Education and Training for Dry Needling.

The Board discussed the information collected by Board staff regarding Dry Needling Regulations in other states. The Board also reviewed a draft message staff was sending to licensees regarding the implementation of SB 1154's decisions. The Board approved the draft provided by staff.

The Board was addressed by Sean Flannagan, PT and Sara Demure, PT regarding their Dry Needling education. Following review and discussion the Board determined to begin the development process for rules setting training and education standards in Dry Needling and hold a period of written comment and schedule a public meeting to hear verbal comment. Ms. Akers, Ms. Hunter, and Mr. Clinton volunteered to be present at the public meeting to liaison on behalf of the Board. The comments will be requested on the following areas: Standards Under Consideration:

- Completion of a dry needling educational course of instruction approved by one of the following entities: Commission on Accreditation in Physical Therapy Education, American Physical Therapy Association, State Chapters of the American Physical Therapy Association, and the Federation of State Boards of Physical Therapy.
- 2. The course of instruction will include a minimum number of hours of instruction. Hours are undetermined at this time.
- 3. The instruction must include:
 - a. Examinations
 - i. A written examination, and
 - ii. An oral examination, and
 - iii. A practical examination.
 - b. Mandatory topics of instruction
 - i. Sterile Needle Procedures as determined by
 - 1. The U.S. Centers for Disease Control and Prevention or
 - 2. The U.S. Occupational Safety and Health Administration
 - c. Advanced Anatomical Review
 - d. Blood Borne Pathogens
 - e. Contraindication and Indications for Dry Needling
 - f. Instruction must be in person, no internet based components in the education
- 4. All treatment of Dry Needling must conform to documentation requirements under A.A.C. R4-24-304.
- 5. The intervention of dry needling cannot be delegated to assistive personnel.
- 6. There will be no mandatory number of years of experience as a licensed physical therapist before completing the standards and legally performing the intervention of dry needling.
- 7. There is no separate consent to treat required before performing dry needling. Consent for treatment is outlined in A.A.C. R4-24-301.
- 8. There will be no required period of supervised clinical practice required.
- 9. A process for verifying compliance with the standards; either
 - a. The Board will implement a free registration process in which a physical therapist will provide proof of compliance with training and education standards and receive confirmation of registration; or
 - b. The licensed physical therapist will be required to provide proof of compliance with the training and education standards upon request form a patient or the Board.
- c) Review, Discussion and Action on Continuing Competence Audit; Complaint Resolution Matrix

The Board discussed the matrix as presented by staff. The Board concurred to place the matrix into policy for the 2014 continuing competence audit of the 22012-2014 compliance period.

d) Review, Discussion and Action on Proposed Assistance In Research Related to NPTE Testing, Suzanne Brown, PT, Ph.D.

Dr. Suzanne Brown was present. The Board requested Mr. Brown, Executive Director, to provide any information on participating or assisting in the process Dr. Susanne Brown has presented. Mr. Brown reported that while the research project appeared important and useful, the Board needed to consider the precedence it would be setting for itself and all other State Agencies if in participated or provided specific assistance in a project. Based the possible impact to the Board the Board declined to participate in the research presented by Dr. Suzanne Brown.
