If you as a Licensed Physical Therapist direct or supervised one or more physical therapist assistants or other assistive personnel including recent graduates, this portion of our bulletin is specifically for you as it is regarding your responsibilities under A.R.S. §32-2043(G) Supervision: patient care management: A physical therapist must verify the qualifications of physical therapist assistants and other assistive personnel under the physical therapist's direction and supervision.
