2) COMPLAINTS, HEARINGS, INVESTIGATIONS and COMPLIANCE

- a) Review and Possible Action on Complaint; Consideration of Consent Agreement:
 - i) Complaint # 10-15; David Guy, P.T.

Dr. Cornwall called the Board's attention to the above matter. Mr. Guy was not present. Mr. Brown provided a summary of the matter for the Board. On August 25, 2009, the Board held an Informal Hearing regarding Case #08-25. The Board found Mr. Guy in violation of law for failure to refer, substandard care, violation of the Code of Ethics, making misleading statements, and failure to create adequate records. Mr. Guy was ordered to complete six months of probation to include 18-20 hours of continuing education. Mr. Guy failed to complete his continuing education as required in the Board Order. Board staff opened a complaint for non-compliance on May 5, 2010. Mr. Guy requested to surrender his license on May 12, 2010. Board staff has drafted a consent agreement for surrender of Mr. Guy's license to practice physical therapy for the Board's consideration. Mr. Brown reported that Mr. Guy has signed the draft consent agreement.

Dr. Cornwall opened the matter for discussion by the Board. Mr. Sieveke questioned Mr. Guy's use of "CPT USA Retired" on his letterhead. Board staff noted it was a reference to Mr. Guy's military service. No other Board member presented questions. Dr. Cornwall moved the board accept the consent agreement as presented. Mr. Robbins seconded the motion. The motion carried by unanimous vote.

- b) Initial Review, Discussion and Action on Complaint
 - i) Complaint # 10-09; Gregory Sonntag, P.T.

Dr. Cornwall called the Board's attention to the above matter. Mr. Sonntag was not present. Ms. Donahue provided the Board with a summary of the complaint filed by C.H., a patient of Mr. Sonntag's, alleging that charges were excessive, communication to his physician was not timely and he was requested to take off his shirt for ultrasound treatment in front of other patients. C.H. has indicated he is legally blind. Ms. Donahue stated Mr. Sonntag had responded to the complaint and summarized the complaint for the Board. Ms. Donahue also noted that the investigation appeared to identify several additional allegations to included, inadequate records, unreasonable fees, failure to adhere to recognized standards of ethics and substandard care.

Mr. Sonntag arrived at the Board meeting while Ms. Donahue concluded her report. Mr. Sonntag came forward and addressed the Board. Mr. Sonntag stated he felt the complaint was baseless; however, the investigation caused him to look at his practice operations and patient care and has made changes. Mr. Sonntag concluded his statement.

Dr. Cornwall opened the matter to questions from the Board. Mr. Sieveke asked Mr. Sonntag to explain the meaning of the handwritten numbers next to patient names on his treatment schedule. Mr. Sonntag stated they are interoffice numbers he uses to identify the total effort used in servicing the patient that day and do not reflect the total units of billing. Ms. Ohlendorf asked Mr. Sonntag if he sees every patient when they arrive or after they begin treatment. Mr. Sonntag stated he sees each patient at least briefly when they arrive. Dr. Cornwall asked how many hours Mr. Sonntag works on his busiest days. Mr. Sonntag stated he works 10-11 hours with two techs on his busiest days. Mr. Sieveke asked Mr. Sonntag what percentage of his patients are Medicare patient. Mr. Sonntag stated it varies, but that when it's busy between November and March about 25% to 30% of patients are Medicare patients. Mr. Sonntag stated that he treats in an open environment and sometimes his aides help with Medicare patients, but that time is not billed. Mr. Sonntag indicated only his time with Medicare patients is billed. Mr. Sonntag stated his aide Emilia would do some manual therapy, but only the therapies he performed where billed.

The Board ended their questions for Mr. Sonntag. Dr. Cornwall asked if any Board member had any issues for discussion. No Board member identified an issue. Dr. Cornwall moved the Board forward this complaint to an Informal Hearing. Mr. Sieveke seconded the motion. The Board entered discussion. Mr. Sieveke asked if Ms. Donahue had interviewed the aide identified as Emilia. Ms. Donahue stated she did not. Dr. Cornwall stated he did not feel it was needed. Ms. Richardson also stated she did not feel Emilia needed to be interviewed. Dr. Cornwall called the motion to a vote. The motion carried by unanimous vote.

ii) Complaint #10-10; James Miller, P.T.

Dr. Cornwall called the Board's attention to the above matter. Mr. Miller was present and the complainant V.K. was present. Ms. Donahue provided the Board with a summary of the complaint. V.K. alleges that Mr. Miller performed a manipulation on her neck without consent that caused injury to her neck, jaw and left arm with episodes of near fainting. The treatment occurred on 10/22/09. V.K. claimed that she requested Mr. Miller to stop the procedure several times, but he failed to stop until after she felt a pop in her neck followed by pain. V.K. claims Mr. Miller explained it was scar tissue causing the pain when they discussed the symptoms at a later visit. V.K. has provided documentation from other health care providers following her care with Mr. Miller. V.K. originally presented to Mr. Miller after a referral for continued physical therapy following a motor vehicle accident.

Dr. Cornwall invited V.K. forward to address the Board. V.K. stated she would like the Board to know she does have a healthcare background. V.K. stated she saw two other physical therapists before treating with Mr. Miller. All three physical therapists were seen in connection with injuries she received as a result of a motor vehicle accident.

V.K. stated her treatment with Mr. Miller originally went well and she progressed to a point of 85-90% relief in her pain and was ready for release from care. However, Mr. Miller suggested an additional month of care. On October 22, 2009 Mr. Miller performed a manipulation on V.K.'s neck by pushing her neck to one side. V.K. stated Mr. Miller had never done that treatment in any other session and had never asked for her consent to perform the treatment. V.K. stated her physician, Dr. Huston, stated there was no necessity to perform the manipulation. V.K. stated she previously believed only chiropractors could perform manipulations and would not have consented to Mr. Miller's manipulation of her neck.

V.K. stated that she requested Mr. Miller stop the manipulation multiple times, but he did not acknowledge her request and she was required to yell before he stopped the manipulation. V.K. claims Mr. Miller stated he must have hit a nerve when she complained of the pain. V.K. stated when she returned on October 29, 2009; Mr. Miller stated she had an acute strain at C2-3 of her neck that was due to scare tissue breaking up. V.K. has been on a soft food diet since the incident and has been diagnosed with TMJ and continues to have spasms pulsing in her ear. V.K. provided the Board with various copies of her medical records from other healthcare providers and finished her statement.

The Board invited Mr. Miller to come forward and make a statement. Mr. Miller stated he had provided his response and was available to answer the Board's questions. Dr. Cornwall asked Mr. Miller if V.K. had asked him to stop the treatment. Mr. Miller stated he had no recollection of such a request. Mr. Sieveke asked V.K. if treatment changed at previous visits. V.K. stated the treatment was the same until October 22, 2009. The Board continued their questions of V.K. and Mr. Miller. Dr. Cornwall concluded the Board's questions and

asked if any Board member had any motions. Mr. Sieveke moved that the Board forward the complaint against Mr. Miller to an Informal Hearing. Ms. Richardson seconded the motion. The Board entered discussions. Dr. Cornwall asked if any further investigation was needed. Mr. Sieveke stated he did not, but wanted to review the information provided in greater detail. Dr. Cornwall called the vote. The motion carried by unanimous vote.
