- d. Review Discussion and Action on Complaint; Further Investigation; Previously Before the Board
 - i) Complaint # 10-32; Raymond Popp, P.T.

Dr. Cornwall called the Board's attention to the above agenda item. Mr. Popp was not present and was not represented by legal counsel. Mr. Brown provided the Board with a summary of the allegations. Mr. Popp was disciplined in the State of Alaska for failure to properly complete continuing competence requirements and surrendered his license to practice physical therapy in Alaska. Mr. Brown reported the Board previously reviewed the case at the August 24, 2010 Board meeting and required Board staff to audit Mr. Popp's 2008-2010 continuing competence activities completed for Arizona. Mr. Brown reported the audit was completed and Mr. Popp was found in compliance. The Board discussed the investigative report. Dr. Cornwall moved the Board dismiss the complaint and issue an non-disciplinary advisory letter to Mr. Popp stating that regardless of the degree of difficulty required to comply with all laws including continuing competence activities. 2) Review, Presentation, Discussion and Action of Federation of State Boards of Physical Therapy Suspension of the National Physical Therapy Examination

Dargan Ervin, President of the Board of Directors, Federation of State Boards of Physical Therapy (FSBPT) was present and accompanied by Susan Layton, Vice President, Federation of State Boards of Physical Therapy. Mr. Ervin and Ms. Layton addressed the Board and provided a presentation on the security of the NPTE and breaches that have caused the FSBPT to suspend registration of the NPTE for graduates from Egyptian, Indian, Pakistani and Philippine programs. The Board discussed the suspension with Mr. Dargan and Ms. Layton following their presentation. No action was required or taken on this agenda item.

The Board questioned C.M. and discussed the investigative record. Dr. Cornwall moved the Board dismiss the complaint and issue a non-disciplinary advisory letter regarding the need to ensure proper communication with patients regarding treatment and billing. The motion failed to produce a second. The Board continued its discussion of the investigation. Mr. Sieveke moved the Board forward complaint 10-13a against Jennifer Hawkins, P.T. to an Informal Hearing and add an allegation of failing to create and maintain adequate records in violation of A.R.S. §32-2044(20) and R4-24-304. v) Complaint # 10-38; Ann Grab, P.T.

Dr. Cornwall called the Board's attention to the above matter. Ms. Grab was present but did not come forward to address the Board. Harvey Kaplan and Frank Johnson, the employers of Ms. Grab, came forward and requested to address the Board. Mr. Brown provided the Board with a summary of the allegation that Ms. Grab failed to renew her license to practice physical therapy in Arizona by the end of the day August 31, 2010 and the license was administratively suspended on September 1, 2010; however, Ms. Grab continued to work on September 1, 2010 and September 2, 2010. Dr. Cornwall allowed Mr. Kaplan and Mr. Johnson to address the Board. Mr. Kaplan explained how Ms. Grab has practiced for numerous years and has never made such a mistake. He stated that it is her job to ensure everyone in the clinic has their licenses active and does a great job of managing that requirement. He stated that Ms. Grab made a mistake and should not receive discipline for the error. Mr. Johnson

addressed the Board and stated Mr. Grab is heavily relied on and does a wonderful job and the offer of discipline to settle the complaint is not appropriate. Mr. Brown summarized the consent agreement offered to Ms. Grab of 90 days probation, take and pass the AZLAW examination, pay a \$100 civil penalty and notify employers, patients and third party payors of the unlicensed practice. The Board discussed the investigation and the necessity of not deviating from the Board's approved discipline matrix for unlicensed practice. Ms Akers moved the Board forward the complaint to an Informal Hearing. Mr. Sieveke seconded the motion. The motion carried by unanimous vote.

- b) Informal Hearing and Possible Action on Complaint:
 - i) Complaint # 10-09; Gregory Sonntag, P.T.

Dr. Cornwall called the Board's attention to the above matter. Mr. Sonntag was present and came forward. Dr. Cornwall provided Mr. Sonntag with a summary of how the hearing would proceed and the possible outcomes of the hearing. Mr. Sonntag was placed under oath by Dr. Cornwall. Dr. Cornwall had all Board members and staff introduce themselves to Mr. Sonntag. Mr. Brown read the allegations that Mr. Sonntag:

- 1. Was the treating physical therapist for patient C.H. from October 2009 thru February 2010.
- 2. Billed for services that are not supported as performed in the patient record or billed for services and time spent providing services that exceeded the time and services documented in the patient record of C.H.
- 3. Failed to ensure that the person providing services documented the services in the patient record and signed their name as providing the services, and failed to co-sign notations in the patient record made by assistive personnel other than certified physical therapist assistants.
- 4. Failed to take into consideration the patient's physical, psychological, or socioeconomic welfare when requiring C.H. to remove his shirt in an open gym area with other persons present.
- 5. Failed to recognize, respect, and respond to the individual and cultural difference of C.H. by requiring him to remove his shirt in an open gym area with other persons present.
- 6. Engaged in the performance of substandard care when providing treatment to C.H. to include an initial evaluation; however, C.H. presented with a neurological pattern of symptoms, rotator cuff tendonous dysfunction, dysfunction related to the scapulothoracic muscles, but Respondent failed to conduct necessary testing to fully evaluate the symptoms or to conclude the diagnosis.
- 7. Engaged in substandard care by failing to create goals and developing a plan of care, based on proper evaluation and assessment, of dysfunctions noted in the initial evaluation of C.H.
- 8. Engaged in substandard care by failing to complete necessary tests during a re-evaluation and providing assessments on a re-evaluation when tests were not performed or documented as performed.
- 9. Failed to maintain adequate patient records for patient C.H. by:
 - a. The daily notes failing to document the therapeutic intervention provided or appropriately supervised and objective tests or measures.
 - b. The re-evaluation failing to document the patient's current functional status, objective dates from tests or measures.

- c. The discharge failing to document patient's current functional status. The discharge states objective measurements that were not documented elsewhere in the patient record.
- d. Assistive personnel not documenting in the patient record when they performed any intervention with the patient.

Dr. Cornwall allowed Mr. Sonntag to make an opening statement. Mr. Sonntag addressed the Board but did not call any witnesses. The complainant C.H. was not present. The Board did not call any additional witnesses. Mr. Sonntag answered questions asked by the Board. Mr. Sonntag provided a closing statement to the Board. The Board entered discussion regarding the investigation and testimony. Dr. Cornwall moved the Board adopted Findings of Fact as follows:

- 1. Mr. Sonntag was the treating physical therapist for patient C.H. from October 2009 to February 2010
- 2. Mr. Sonntag failed to document or cause to be documented the activities Mr. Sonntag delegated to assistive personnel to be performed in connection with the treatment of C.H.
- 3. Mr. Sonntag failed to create and maintain adequate patient records that supported the treatments billed as performed or provided to C.H.
- 4. Mr. Sonntag's discharge evaluation and discharge summary was conducted verbally, but was not properly documented in the patient record for patient C.H. The discharge summary failed to include documentation of how objective measurements data was obtained and the patient record did not contain the data in any other documentation.

Ms. Akers seconded the motion. The motion carried by unanimous vote.

The Board entered discussion regarding the proper order to issue Mr. Sonntag. Following the end of discussion Dr. Cornwall moved the Board issue Mr. Sonntag an Order to be placed on probation for 12 months with possible early termination following completion of the terms, a requirement to take 8 hours of continuing education in ethics and 8 hours in documentation which are in addition to continuing competence activities required for renewal purposes and must be preapproved by Board staff. The continuing education must be completed in 6 months from the effective date of the order. Mr. Sonntag will take and pass the AZLAW examination within 3 months of the effective date of this order. Mr. Sonntag will undergo a minimum of one audit of his patient files by Board staff to include at least one Medicare patient, and one privately insured patient. The audit must be completed after Mr. Sonntag completes the ordered continuing education, if Board staff finds the audit demonstrates records below the standard in law staff may require one additional audit. Mr. Sonntag may petition the Board if an

additional audit is required. Mr. Sonntag must seek termination of the probation. Ms. Richardson seconded the motion. Dr. Cornwall ordered a roll call vote. The motion carried by unanimous vote.

- a) Formal Hearing and Possible Action
 - i) 12:25 p.m. Complaint #10-16; Heath Jabs, P.T.

Dr. Cornwall calls the Board's attention to the above agenda item. Mr. Jabs is not present and is not represented by legal counsel. Mr. Brown affirms that the required notice of hearing was sent to all addresses of records for Mr. Jabs by certified and standard mail. Dr. Cornwall read aloud the hearing procedures and the possible outcome of the hearing. The allegations and complaint notice where provided to the Board.

- 1) On or about March 18, 2010, Respondent entered into Consent Agreement and Order #09-23 with the Board. The Consent Agreement contains Findings of Fact that Respondent reported to work on May 28, 2009 impaired and under the influence of alcohol.
- 2) Respondent is required to pay a civil penalty, complete continuing education, enter substance abuse monitoring, undergo biological fluid testing, and abstain from the use of controlled substances and use of alcohol.
- 3) On or about April 26, 2010, the Board's Executive Director, Charles Brown, received information from Heath Jabs, Respondent, that he had relapsed in his substance abuse and was in the processing of making arrangements to enter substance abuse treatment in Michigan.
- 4) On or about, May 18, 2010, Board staff initiated a complaint against Respondent's license for violation of the terms of the consent agreement with the Board. Board staff has failed to establish any contact through standard mail correspondence.
- 5) Respondent has communicated with Board staff by responding to an e-mail notification of a complaint with a written response to the complaint allegations on June 17, 2010. Board staff has been unable to verify Respondent's address of record since June 17, 2010. All mailings to Respondent's address in Michigan have been returned without a forwarding address.
- 6) Respondent's presence in a substance abuse treatment program cannot be confirmed and the Board cannot confirm or deny if Respondent is engaged in the practice of physical therapy in the State of Arizona or any other jurisdiction.
- 7) The facts as presented demonstrate that the public health, safety or welfare imperatively requires emergency action.

Ms. Verstegen provided an opening statement for the State. Respondent had no opening statement as he was not present. Mr. Brown was called to provide testimony on behalf of the State. Mr. Brown was sworn-in by Dr. Cornwall. Mr. Brown provided testimony of all exhibits offered by the State to include testimony of Mr. Jabs self reported substance abuse relapse and failure to inform the Board of his address of residence or work. Dr. Cornwall accepted all exhibits into the record. Ms. Verstegen concluded her direct questioning of Mr. Brown. No cross examination was offered by respondent. The Board did not question Mr. Brown. Ms. Verstegen provided a closing statement. The Respondent did not provide a closing statement. The Board entered discussion. Dr. Cornwall asked if any Board member had any questions. No questions where expressed. Dr. Cornwall moved the Board adopt the Factual Allegations listed in the complaint as the Findings of Fact. Mr. Robbins seconded the motion. Mr. Brown reported that the Board's memo described the terms of Mr. Sifling's Board Order that Mr. Sifling may have violated including the use of controlled substances and the receipt of disciplinary action at his place of employment. Mr. Brown reported the matter is before the Board to consider Mr. Sifling's compliance with the terms of the Board Order and to consider lifting the stay on the revocation of his license.

Mr. Sifling provided the Board with a statement. Mr. Sifling admitted to his substance abuse relapse and explained the stress he endured while working. Mr. Sifling stated he never worked while under the influence. Once Mr. Sifling concluded his statement the Board entered discussion. Following some Board discussion Dr. Cornwall moved the Board enter Executive Session for the purpose of obtaining legal advice. Ms. Akers seconded the motion. The motion carried by unanimous vote.
