- b) Informal Hearing and Possible Action on Complaint:
 - i) Complaint #11-18; David Dumyahn, PT

Mr. Dumyahn was present and was not represented by legal counsel. Mr. Dumyahn was sworn in by Ms. Richardson. Ms. Richardson provided a summary of how the proceeding would run and the possible outcomes. The Board and staff introduced themselves. Mr. Brown summarized the complaint. Mr. Dumyahn addressed the Board. The Board asked questions of Mr. Dumyahn. Ms. Richardson concluded the questioning and testimony phase of the hearing. The Board deliberated.

Ms. Richardson moved the Board adopt the following Findings of Fact:

- 1. The Arizona Board of Physical Therapy is that body politic created and empowered pursuant to A.R.S. §32-2001, *et seq.* to administer the laws of the State of Arizona relating to the practice of physical therapy.
- 2. Respondent is the holder of **License** No. 1698 to practice as a physical therapy in the state of Arizona and was the treating physical therapist for patient D.B.
 - 3. Respondent was the treating physical therapist for patient D.B.
 - 4. Respondent engaged in substandard care by:
- a. The initial evaluation does not include all objective tests and measurements that would be necessary to determine appropriate diagnosis and treatment.
- b. A goal, in the initial evaluation to "increase UE strength" was inappropriate as the evaluation indicated the strength of the UE to be WNL.
- c. A goal, in the initial evaluation to "increase core strength" was inappropriate, as strength measurements for the abdominal and pelvic stabilizers were not measured.
 - d. There are several lapse of care over 4 weeks in which a re-evaluation was not performed:
 - i. 4/4/08
 - ii. 12/12/08
 - iii. 2/27/09
 - iv. 3/6/09

- v. 4/14/09
- vi. 6/10/09
- vii. 8/11/10
- e. Re-Evaluations, throughout the 4 year episode of care, did not adequately contain:
 - i. Objective tests or measurements
 - ii. Patient's subject report
 - iii. Patient's current functional status
 - iv. The patient's response to treatment
 - v. Rationale for continuation of care
 - vi. Progress towards achievement of goals
- f. Re-Evaluations were not performed following:
 - i. 5/23/08 When patient complained of new symptoms of low back pain and burning with standing
 - ii. 10/27/08 following kidney stone surgery
 - iii. 3/6/09 following shunt surgery
 - iv. 10/21/09 following hand fracture
 - v. 12/09/09 When patient reports that he injured his back at school.
 - vi. 3/3/10 documents open sores in bilateral LE due to new AFO's
 - vii. 8/11/10 following undisclosed surgery
 - viii. 9/29/10 following shunt surgery and reports of bulging discs at L4-L5
 - ix. 11/10/10 following reports of left knee patella subluxation
- g. Manual Therapy and application of modalities are performed and removed from the POC without justification or rationale.
- h. Respondent initiates treatment for the bilateral shoulders, cervical and thoracic spine without performance of an evaluation in several incidences throughout the patient record
- i. 10/6/10 Subjective states no exercise. However, exercise is listed as being performed in the daily documentation.
 - j. Lumbar evaluation following surgery for L2-L3 discectomy on 1/19/1.1
 - Balance was not assessed
 - ii. Gait description was illegible
 - iii. Objective tests and measures were not complete
 - iv. Neurological testing was not performed/documented
 - v. Goals were not appropriate to support the evaluative findings
 - vi. Therapists interpretation of the results of the examination was not documented

- vii. Clinical rationale for therapeutic interventions was not documented
- viii. Plan of care may have failed to identify measureable goals
- k. Treatment is initiated without any objective tests or measures to indicate DX or source of symptoms.
 - 5. Respondent engaged in failure to maintain adequate patient records:
 - a. Many sections of numerous daily notes are illegible.
 - b. A majority of daily notes failed to document:
 - i. Patients subjective report
 - ii. The therapeutic intervention provided or appropriately supervised
 - iii. Patients response to the therapeutic intervention
 - iv. Objective data from tests or measures, if collected
 - c. Plan of the majority of daily notes is "see QW"
 - d. Assessment for the majority of daily notes "tolerated well"
 - e. Goals in both initial evaluations were not congruent with the findings of the evaluation
 - f. Manual therapy parameters were not documented in all daily notes.
 - g. The majority of Re-evaluations failed to document:
 - i. Objective tests or measurements
 - ii. The patient's subjective report
 - iii. The patients response to treatment
 - iv. Assessment of the patients progress
 - v. Patients current functional status
 - vi. Rationale for continuation of care
 - vii. Any change in the plan of care

Ms. Richardson moved the Board adopt the following Conclusions of law:

1. The Board has jurisdiction over this matter pursuant to A.R.S. § 32-2001, *et seq.* and the rules promulgated by the Board relating to the practice of physical therapy.

- 2. The conduct and circumstances explained in the Findings of Fact above constitute a violation of A.R.S. §32-2044(1) ("Violating this chapter, board rules or a written board order.").
- 3. The conduct and circumstances explained in the Findings of Fact above constitute a violation of A.R.S. §32-2044(4) ("Engaging in the performance of substandard care by a physical therapist due to a deliberate or negligent act or failure to act regardless of whether actual injury to the patient is established.")
- 4. The conduct and circumstances explained in the Findings of Fact above constitute a violation of A.R.S. §32-2044(20) ("Failing to maintain adequate patient records. For the purposes of this paragraph, "adequate patient records" means legible records that comply with board rules and that contain at a minimum and evaluation of objective findings, a diagnosis, the plan of care, the treatment record, a discharge summary and sufficient information to identify the patient".)

R4-24-303. Patient Care Management:

- A. A physical therapist is responsible for the scope of patient management in the practice of physical therapy as defined by A.R.S. § 32-2001. For each patient, the physical therapist shall:
 - 1. Perform and document an initial evaluation;
 - 2. Perform and document periodic reevaluation;
 - 3. Document a discharge summary and the patient's response to the course of treatment at discharge;
 - 4. Ensure that the patient's physical therapy record is complete and accurate; and
- 5. Ensure that services reported for billing, whether billed directly to the patient or through a third party, are accurate and consistent with information in the patient's physical therapy record.
 - B. On each date of service, a physical therapist shall:
- 1. Perform and document each therapeutic intervention that requires the expertise of a physical therapist; and
- 2. Determine, based on a patient's acuity and treatment plan, whether it is appropriate to use assistive personnel to perform a selected treatment intervention or physical therapy task for the patient.

A.A.C. R4-24-304: Adequate Patient Records:

- A. A physical therapist shall ensure that a patient record meets the following minimum standards:
- 1. Each entry in the patient record is:
 - a. Legible,
 - b. Accurately dated, and
 - c. Signed with the name and legal designation of the individual making the entry;
- 2. If an electronic signature is used to sign an entry, the electronic signature is secure;
- 3. The patient record contains sufficient information to:
 - a. Identify the patient on each page of the patient record,
 - b. Justify the therapeutic intervention,
 - c. Document results of the therapeutic intervention,
 - d. Indicate advice or cautionary warnings provided to the patient,
 - e. Enable another physical therapist to assume the patient's care at any point in the course of therapeutic intervention, and
 - f. Describe the patient's medical history.
- 4. If an individual other than a physical therapist or physical therapist assistant makes an entry into the patient record, the supervising physical therapist co-signs the entry;
 - 5. If it is determined that erroneous information is entered into the patient record:
 - a. The error is corrected in a manner that allows the erroneous information to remain legible, and
 - b. The individual making the correction dates and initials the correct information; and
- 6. For each date of service there is an accurate record of the physical therapy services provided and billed.
- B. Initial evaluation. As required by A.R.S. § 32-2043(F) (1), a physical therapist shall perform the initial evaluation of a patient. The physical therapist who performs an initial evaluation shall make an entry that meets the standards in subsection (A) in the patient record and document:
 - 1. The patient's reason for seeking physical therapy services;

- 2. The patient's relevant medical diagnoses or conditions;
- 3. The patient's signs and symptoms;
- 4. Objective data from tests or measurements;
- 5. The physical therapist's interpretation of the results of the examination;
- 6. Clinical rationale for therapeutic intervention;
- 7. A plan of care that includes the proposed therapeutic intervention, measurable goals, and frequency and duration of therapeutic intervention; and
- 8. The patient's prognosis.
- C. Therapeutic-intervention notes. For each date that a therapeutic intervention is provided to a patient, the individual who provides the therapeutic intervention shall make an entry that meets the standards in subsection (A) in the patient record and document:
 - 1. The patient's subjective report of current status or response to therapeutic intervention;
 - 2. The therapeutic intervention provided or appropriately supervised;
 - 3. Objective data from tests or measures, if collected;
 - 4. Instructions provided to the patient, if any; and
 - 5. Any change in the plan of care required under subsection (B) (7).
- D. Re-evaluation. As required by A.R.S. § 32-2043(F)(2), a physical therapist shall perform a re-evaluation when a patient fails to progress as expected, progresses sufficiently to warrant a change in the plan of care, or in accordance with R4-24-303(F)(4). A physical therapist who performs a re-evaluation shall make an entry that meets the standards in subsection (A) in the patient record and document:
 - 1. The patient's subjective report of current status or response to therapeutic intervention;
 - 2. Assessment of the patient's progress;
 - 3. The patient's current functional status;
 - 4. Objective data from tests or measures, if collected;
 - 5. Rationale for continuing therapeutic intervention; and
 - 6. Any change in the plan of care required under subsection (B)(7).
- E. Discharge summary. As required by A.R.S. § 32-2043(F) (3), a physical therapist shall document the conclusion of care in a patient's record regardless of the reason that care is concluded.
- 1. If care is provided in an acute-care hospital, the entry made under subsection (C) on the last date that a therapeutic intervention is provided constitutes documentation of the conclusion of care if the entry is made by a physical therapist.
- 2. If care is not provided in an acute-care hospital or if a physical therapist does not make the entry under subsection (C) on the last date that a therapeutic intervention is provided, a physical therapist shall make an entry that meets the standards in subsection (A) in the patient record and document:
 - a. The date on which therapeutic intervention terminated;
 - b. The reason that therapeutic intervention terminated;
 - c. Inclusive dates for the episode of care being terminated;
 - d. The total number of days on which therapeutic intervention was provided during the episode of care;
 - e. The patient's current functional status;
 - f. The patient's progress toward achieving the goals in the plan of care required under subsection (B) (7); and
 - g. The recommended discharge plan.

Ms. Hunter seconded the motion. Following review and discussion the motion carried by unanimous vote.

ii) Complaint #11-53; Arnold Gonzales, PT

Mr. Gonzales was present and was not represented by legal counsel. Mr. Gonzales was sworn in by Ms. Richardson. Ms. Richardson summarized the proceeding and its possible outcomes. The Board and staff introduced themselves. Mr. Brown summarized the complaint against Mr. Gonzales. Mr. Gonzales made statements and answered questions from the Board. Ms. Richardson closed the testimony phase of the hearing. The Board entered deliberations.

Ms. Richardson moved the Board adopt the following Findings of Fact:

- 1. The Arizona Board of Physical Therapy is that body politic created and empowered pursuant to A.R.S. §32-2001, *et seq.* to administer the laws of the State of Arizona relating to the practice of physical therapy.
- 5. Respondent is the holder of **License** No. 8660 to practice as a physical therapist in the state of Arizona.
 - 6. Failed to adhere to the recognized standards of ethics; and,
 - 7. Charged unreasonable or fraudulent fees for services performed or not performed.
- a. The complainant interviewed each of the three patients identified in the complaint and confirmed that they were cognitively sound. Each of the three patients reported that they did not receive physical therapy services from Mr. Gonzales:
 - i. M.L. 10/14/11
 - ii. N.M. 10/6/11
 - iii. S.W. 10/19/11
- b. Mr. Gonzales confirms that the notes written on these dates for these patients were documented and electronically signed by his electronic signature.
- c. During his interview, Mr. Gonzales states for patient M.L. "I definitely could have pre-written the note and he was sick and I did not go back and see him and take the note out," Confirming it was possible that he pre-wrote a note/billing and failed to modify the documentation following the patient cancelling.
- d. In review of patient record N.M., Mr. Gonzales's documentation on 10/6/11 is identical to the documentation produced by Ms. Holly Acosta, PTA on visit prior on 10/5/11. It is unlikely that the am nursing staff was provided training for SPT on two consecutive days. Mr. Gonzales may have copied this note and

billed prior to providing patient care. Mr. Gonzales documented treatment and billed for 50 minutes (15 minutes of gait training and 35 minutes of therapeutic activities).

- e. In review of patient record S.W. on 10/19/11, Mr. Gonzales documents "This intervention is medically necessary in order to increase strength which will translate into increased level of functional independence for transfers and ambulation. Pt states she would like to do individual BLE exercises on her own in her room throughout the day. PT agreed." Mr. Gonzales billed 30 minutes of therapeutic exercise on this date of service.
 - i. Ms. Wilson states, when interviewed by Ms. Reed (as documented in the patient record received) "In morning Theresa wasn't there and Albert or Arnold said he would come and get me (too busy in the morning). I did sleep in daytime- but didn't turn down any therapy".
- f. In review of patient record M.L on 10/14/11, Mr. Gonzales documents "Nu step X 12 step on level 1, pt tolerates tx well. Pt participated in gait training and ambulated with FWW SBA X 60". With the exception of the distance modified from 40' to 60', Mr. Gonzales documentation is identical to the documentation produced by Ms. Regina Manion, PTA the treatment prior on 10/13/11. Mr. Gonzales may have copied this note and billed prior to providing patient care. Mr. Gonzales documented treatment and billed for 30 minutes (20 min therapeutic exercise and 10 min of gait training).
- g. The billing time may not be consistent with the documented treatment time instructed or performed.

 - i. The patient's subjective report is not documented
