#### 5) BOARD BUSINESS AND REPORTS

c) Review and Discussion; Stakeholder Input; Dry Needling;

Mr. Brown reviewed materials received throughout the Board's Stakeholder process and the material presented during the Board Dry Needling Study Group process. Mr. Brown presented the Board with options in scheduling a time and place for the Board to formally discuss the Dry Needling topic and to consider taking action on the matter. The Board discussed holding a separate meeting or scheduling the matter for a specific time at a Regular Scheduled meeting.

Dr. Miller stated his wish to have the matter scheduled at the regular Scheduled October meeting. Dr. Miller reviewed some the material already presented to the Board to include the FSBPT Dry Needling resource Paper (Intramuscular Manual Therapy) 4<sup>th</sup> Edition, the Arizona Physical Therapy Association Position, and the American Physical Therapy Association Dry Needling Resource Paper. Dr. Miller requested the Board consider placing the following statement on the Board website:

Returning to the four tenets from *Changes in Healthcare Professions Scope of Practice: Legislative Considerations* on which to base scope of practice decisions and summarizing the information above, it appears there is a historical basis, available education and training as well as an educational foundation in the CAPTE criteria, and supportive scientific evidence for including dry needling in the scope of practice of physical therapists. The education, training and assessment within the profession of physical therapy include the knowledge base and skill set required to perform the tasks and skills with sound judgment. It is also clear, however, that dry needling is not an entry-level skill and should require additional training.

Dr. Zook asked Mr. Brown how the Board may receive any further public comments on the matter. Mr. Brown reviewed the Board process for already receiving public comment over the past year to include the statewide public meetings and substantial periods for taking written comment. Mr. Brown recommended the Board leave the written comment period open until October 11, 2013, which is the material deadline for the October 22, 2013 Board meeting and consider holding a call to the public before entering into the Board's Dry Needling discussion, which would allow for new comments, but still allow the Board sufficient time to discuss and debate the matter. The Board discussed their scheduling options. After reaching consensus, Ms. Akers directed staff to place the topic of Dry Needling on the Board's October 22, 2013 Agenda for discussion to begin at 1:00 pm and
