iii) Complaint #13-26; Malory Huff, PT

Ms. Huff was present and was represented by legal counsel Fred Cummings. Ms. Donahue and Ms. Huff were sworn in by Ms. Akers. The Board members introduced themselves. Mr. Brown summarized complaint for the Board. Ms. Huff addressed the Board and answered questions asked by the Board. After the Board heard all testimony and allowed all parties to make statements. The Board entered deliberation. Following deliberation Ms. Akers moved to accept the following Findings of Facts:

A. Respondent failed to supervise assistive personnel, physical therapy students or interim permit holders in accordance with this chapter and rules adopted pursuant to this chapter."

- 1. Ms. Huff's written responses are in conflict with her telephone interview:
 - a. (Response) The PTA would call this PT to discuss patient care and patient's progress.

- i. *(Interview)* Ms. Huff in her phone interview stated that she generally did not talk to Mr. Spillman by phone, but rather left notes on various patients at the end of the day for him to provide treatment the following day.
- b. (*Response*) When this PT was on-site, PTA and PT discussed the patients and how the patients were progressing with the plan of care.
 - i. June 29, 2013
 - 1. *(Interview)* Ms. Huff is in the building. Mr. Spillman documents that he talked with you on the phone. Mr. Spellman thinks you are not in the facility. Did you talk to him? How does he not know you are in the facility on this day? "I do not know"
 - 2. (*Patient Record*) Mr. Spillman, PTA indicates he is under general supervision by Ms. Huff.
 - 3. (*Interview*) Ms. Huff is working in the same facility on this date of service.
 - ii. July 6, 2013
 - 1. (*Patient Record*)Ms. Huff is in the facility. Mr. Spillman does not document that he is aware that Ms. Huff is in the facility.
 - iii. July 9, 2013
 - 1. (*Interview*) Ms. Huff is in the facility on this date. Were skilled services provided by the therapist? Did you treat her this day? "No" I think Mr. Spillman is indicating that I was on-site. I did not delegate traction to the right hip." Did Mr. Spellman inform you of the hip pain? "No"
 - 2. (*Patient Record*) Mr. Spillman, PTA documents that he is under general supervision of Ms. Huff. Ms. Huff is in the facility on this date of service.
- c. (*Response*) All patient evaluations and plans of care were provided by a physical therapist and treatment was carried out according to the plan of care.
 - i. June 27, 2013 (Interview)
 - 1. Did you delegate traction? "No I did not."
 - 2. How did the PTA that you are supervising perform a treatment intervention that you did not delegate?
 - a. Ms. Huff's response: "When I talked to him about the patient I said "what did you do" he said "manual traction" and I asked for what? I said do not do that- Mr. Spillman stated that she was saying that she was having pain.
 - b. Where was traction provided? I do not know.
 - c. Did you ask him to stretch or provide myofascial release? "No"
 - d. None of the manual treatment I delegated.
 - ii. June 27, 2013 (Patient Record)
 - 1. Mr. Spillman, PTA indicates he is under general supervision by Ms. Huff.
 - 2. Mr. Spillman documents manual therapy:
 - a. Stretching of shortened connective tissue (does not identify tissue or technique)
 - b. Myofascial release (does not identify tissue or technique)
 - c. Manual traction (no parameters, does not indicate joint)
 - iii. July 2, 2013 (Interview)
 - 1. I did not delegate myofascial release to the both shoulders

- 2. Second time in the same week Mr. Spillman is performing non-delegated treatment. If you are reviewing notes at the end of the day how did you miss this? "I did not look at notes on this day"
- 3. Why does Mr. Spillman document increasing ROM and flexibility activities? "I do not know what that is, I do not know if it is part of a preset sentence or not."
- iv. July 2, 2013 (Patient Record)
 - 1. Manual Therapy: Myofascial release to both shoulders to decrease pain. Shoulders were not assessed in the patient record.
 - 2. No documentation that Mr. Spillman communicated with Ms. Huff the change in status of the patient or his change in the plan of care to provide myofascial release to the shoulders.
 - July 3, 2 Mr. Spillman documents manual therapy again. You already have told him not to perform. What do you believe he is putting traction on or stretching? "I do not know, I did not delegate it"
- v. July 3, 2013 (Interview)
 - 1. Mr. Spillman documents manual therapy again. You already have told him not to perform. What do you believe he is putting traction on or stretching? "I do not know, I did not delegate it"
- vi. July 3, 2013 (Patient Record)
 - 1. Manual Therapy: Manual traction and stretching of shortened tissue to entire LLE.
- vii. July 4, 2013 (Interview)
 - 1. The only treatment provided is manual therapy. Documents that a manipulation was performed. Did you read the notes? "No"
- viii. July 4, 2013 (Patient Record)
 - 1. Documents that he performed manipulation techniques.
 - 2. Documents stretching of shortened connective tissue.
 - 3. Documents myofascial release
- ix. July 5, 2013 (Interview)
 - 1. Manual therapy with traction to the low back. There does not seem to have any communication between you and Mr. Spillman. "I do not understand why he is doing that for pain relief."
- x. July 5, 2013 (Patient Record)
 - 1. Manual therapy
 - a. Stretching, myofascial release and manual traction to patient's low back for pain relief.
 - b. Documentation does not indicate the Mr. Spillman communicated with MS. Huff regarding the patient's change in status or Mr. Spillman's change in the plan of care for treatment.
- xi. July 9,2013(*Interview*)
 - 1. Mr. Spillman documents performance of manual traction to right hip. Ms. Huff has not evaluated the right hip
 - i. Were skilled services provided by the therapist? Did you treat her this day? "No" I think Mr. Spillman is indicating that I was on-site. I did not delegate traction to the right hip." Did Mr. Spillman inform you of the hip pain? "No"

- ii. Did you look at this note afterwards? "No" Did Mr. Spillman tell you he performed traction to the hip? "No"
- xii. July 9, 2013 (Patient Record)
 - 1. Manual therapy:
 - a. Stretching tissue and technique not identified
 - b. Myofascial release: tissue and technique not identified
 - c. Manual traction to right hip (Right hip was not assessed in the initial evaluation)
 - 2. Mr. Spillman does not document communication with Ms. Huff when he changes the treatment plan to include traction of the right hip.
- xiii. July 10, 2013 (Interview)
 - 1. "Too painful 9/10 R LE" Mr. Spillman provided traction to the hip the day before and now the patient is reporting 9/10 pain. Did Mr. Spillman inform you of this change of status? "No"
 - 2. Did you look at this note? "Not this date"
 - 3. Why do you continue to delegate to Mr. Spillman? "I do not have an answer, I do not know"
- xiv. July 10, 2013 (Patient Record)
 - 1. Mr. Spillman documents that the patient has a significant change in status with reports of 9/10 pain to the RLE. (Same extremity that he documented performing traction the day prior)
 - 2. Mr. Spillman documents he performs manual therapy on this date of service that includes traction, stretching and myofascial release.
- xv. July 16, 2013 (Interview)
 - 1. Did you delegate joint mobilization? "No"
 - 2. Did you talk to him on this day "I do not know"
- 2. Ms. Huff failed to maintain responsibility for patient care of MN given by Mr. Spillman under her supervision.
 - a. Ms. Huff states that she may not have communicated or delegated on a daily basis.
 - b. Ms. Huff failed to remove Mr. Spillman from the care of MN when she determined that Mr. Spillman as not following her plan of care or delegation.
 - c. Ms. Huff failed to review the patient record when Mr. Spillman provided treatment to NM
 - d. Ms. Huff failed to provide any treatment to MN following the initial evaluation
 - e. Ms. Huff does not document after the initial evaluation in the patient record that she was involved in the care of NM.
 - f. Ms. Huff failed to re-assess MN when her current functional status changed, PTA reported an increase in symptoms or when required by law under the general supervision rules.
- 3. Ms. Huff failed to determine on each date of service, based on MN acuity and treatment plan, whether it was appropriate to use assistive personnel to perform selected treatment interventions.
 - a. Ms. Huff confirms in her interview:
 - i. She did not delegate to Mr. Spillman on a daily basis.
 - ii. She was unaware of any change in status of MN throughout the course of treatment.
 - iii. She continued to delegate physical therapy services of MN to Mr. Spellman, even though she was aware the Mr. Spillman was not following her delegation.
 - b. The patient record fails to document any specific delegation that Ms. Huff provided to Mr. Spillman.

- 4. Ms. Huff failed to perform a re-evaluation and provide each therapeutic intervention for MN on the forth and subsequent visits.
 - a. Mr. Spillman provides physical therapy services to MN for 12 visits, under general supervision, without documentation of Ms. Huff engaging in the care of MN after the initial evaluation.
- 5. Ms. Huff failed to ensure that the physical therapy services provided ensured that the delivery of care was safe, effective and efficient.
- **B.** Respondent engaged in the performance of substandard care by a physical therapist due to deliberate or negligent act or failure to act regardless of whether actual injury to the patient is established.
 - **1.** Ms. Huff performs the initial evaluation for MN on 6/26/13 and does not document any other entry into the patient record indicating that she provides any further treatment over the course of 14 visits in which she was the supervising physical therapist for Mr. Spillman, PTA.
 - a. Ms. Huff is documented as providing general supervision for Mr. Spillman, PTA.
 - **i.** Ms. Huff confirms in her interview that she did not delegate care of MN on a daily basis to Mr. Spillman.
 - **ii.** Ms. Huff failed to review the patient's record to determine if Mr. Spillman was providing appropriate treatment as delegated.
 - iii. Ms. Huff, when noted that Mr. Spillman was providing care that was not delegated, specifically manual therapy,
 - 1. Did not remove Mr. Spillman from MN care.
 - 2. Did not re-evaluate or perform treatment to MN.
 - **2.** Ms. Huff failed to re-evaluate MN when the documentation from Mr. Spillman, PTA indicates that the patient status had changed.
 - **a.** 6/28/13 Mr. Spillman documents complaints of pain. 0/10 pain was documented at the initial evaluation.
 - **b.** 7/2/13 Mr. Spillman documents pain in both shoulders. Shoulders were not assessed by Ms. Huff at the initial evaluation.
 - c. 7/4/13 Mr. Spillman documents performance of a manipulation to undefined joint.
 - **d.** 7/5/13 Mr. Spillman documents performance of manual traction to low back for pain relief. Ms. Huff did not assess the lumbar spine in the initial evaluation.
 - **e.** 7/9/13 Mr. Spillman documents performance of manual traction to right hip. Right hip was not assessed in the initial evaluation.
 - **f.** 7/10/13 Mr. Spillman documents 9/10 pain in the right LE.
 - **g.** 7/16/13 Mr. Spillman documents performance of joint mobilization. Ms. Huff documents LE ROM to be WFL in the initial evaluation.

C. Respondent failed to report to the board any direct knowledge of an unprofessional, incompetent or illegal act that appears to be in violation of this chapter or board rules.

- **1.** Ms. Huff failed to notify the board when the direct supervision rules were not maintained for patients at La Mesa.
- **2.** Ms. Huff failed to notify the board when Mr. Spillman performed non-delegated treatment to MN.

- **D.** Respondent failed to maintain adequate patient records. For the purposes of this paragraph "adequate patient records" means legible records that comply with Board rules and that contain at a minimum and evaluation of objective findings, a diagnosis, the plan of care, the treatment record, a discharge summary and sufficient information to identify the patient.
 - 1. 6/26/13 Initial Evaluation
 - i. Objective measurements:
 - 1. LE ROM: BLE ROM=WFL
 - 2. ABLE strength: 3+/5
 - 3. Pain: 0/10
 - ii. Goals:
 - 1. "Increase LE strength to 4-/5 to facilitate improved functional mobility and to decrease risk for falls"
 - a. Is not measurable.
 - b. Specific muscles testing in the LE were not documented (3+/5 for all muscles bilaterally in the LE may not be accurate assessment for strength given that the same test score for every muscle is recorded)
 - 2. "Increase LE strength to 4/5 to facilitate improved functional mobility and to decrease risk for falls"
 - a. Is not measurable.
 - b. Specific muscles testing in the LE were not documented (3+/5 for all muscles bilaterally in the LE may not be accurate assessment for strength given that the same test score for every muscle is recorded)
 - iii. Specific treatment provided is not documented.
 - iv. The physical therapists interpretation of the results of the examination is not documented.
 - v. Clinical rationale for therapeutic intervention is not documented

Respondent Violated:

- 1. <u>A.R.S. §32-2044(1)</u>: "Violating this chapter, board rules or a written board order."

- 3. <u>A.R.S. §32-2044(17)</u> "Failing to report to the board direct knowledge of an unprofessional, incompetent or illegal act that appears to be in violations of this chapter or board rules."
- 4. <u>A.R.S. §32-2044(20)</u> "Failing to maintain adequate patient records. For the purposes of this paragraph, "adequate patient records" means legible records that comply with board rules and that contain at a minimum an evaluation of objective findings, a diagnosis, the plan of care, the treatment record, a discharge summary and sufficient information to identify the patient."

In addition, a random audit of 3 charts with the first one to take place after Continuing Education courses are completed, a 30 minute presentation to be given to 20 PT/PTA students on Supervision, Documentation, and patient care. iv) Complaint #13-27; Anthony Spillman, PTA

Mr. Spillman was present and was represented by legal counsel David Cohen. Introductions were made and Ms. Donahue and Mr. Spillman were sworn in. Mr. Brown summarized complaint for the Board. Mr. Cohen addressed the Board. Mr. Spillman answered questions asked of him by the Board. Following the hearing of all testimony and allowing all parties to make statements the Board entered deliberations. Following deliberations Ms. Akers moved to adopt Findings of Facts as follows:

- A. Respondent engaged in substandard care by a physical therapist assistant, including exceeding the authority to perform tasks selected and delegated by the supervising licensee regardless of whether actual injury to the patient is established.
 - 1. Mr. Spillman, PTA does not document communication with his supervising physical therapist when the patient's status and function are adversely changed for patient MN.
 - a. 7/2/13
 - b. 7/5/13
 - c. 7/9/13
 - d. 7/10/13
 - 2. Mr. Spillman, PTA confirms in his interview that he did not received daily delegation from the supervising physical therapist.
 - 3. Mr. Spillman, PTA confirms in his interview that he independently made treatment intervention decisions without direction by or communication with his supervising physical therapist.

- 4. Mr. Spillman, PTA by providing manual therapy to patient MN may have provoked a decrease in function and increase in pain when he performed traction to the right hip on 7/9/13.
- 5. Mr. Spillman, PTA documented progress notes which would have exceeded the authority to perform when he documented: the instruction given by the physical therapist, progress, discharge plan, impairments, rehab potential and clinical impressions sections of the progress note.
- 6. Mr. Spillman, PTA documents the performance of a manipulation on 7/4/13 which may have exceeded the authority to perform.

B. Respondent charged unreasonable or fraudulent fees for services performed or not performed.

- 1. Mr. Spillman, PTA charged for services, specifically manual therapy, in which he was not delegated to perform by his supervising physical therapist.
 - a. 7/4/13
 - b. 7/5/13
 - c. 7/6/13
 - d. 7/9/13
 - e. 7/10/13
 - f. 7/11/13
 - g. 7/16/13
- 2. Mr. Spillman, PTA charged for physical therapy services in which the documentation does not support the billing.
 - a. 6/29/13 wheelchair management

C. Respondent failed to report to the board direct knowledge of an unprofessional, incompetent or illegal act that appears to be in violations of this chapter or board rules."

- 1. Mr. Spillman, PTA confirms in his interview that he was not abiding by the general supervision rules when he continued to provide treatment to patient MN after the 3rd visit under general supervision.
